

FORGING A LEGACY: ARROW CORPS 5

From June 21 to June 28, 2008 a contingent from Lowwapaneu was participating in the OA's national service project: ArrowCorps5. The premise was simple: five sites, five weeks, five thousand arrowmen. At each of the sites, approximately one thousand arrowmen would perform cheerful service pertinent to the needs of each area. George Washington and Jefferson National Forests, the site Lowwapaneu's contingent was at, had service that included building over 7 miles of multi-user hiking trails.



Our contingent, which included Chris Naticchi (who served as chairman), Carl Jurkowski, Trevor Schirra, Erik Hayden, Kris Tomaine, Mr. Ed Allen, Mr. Mike Jurkowski, Mr. Tino Penzone, Mr. Jim Naticchi, and Mr. Mike Minello (who served as adviser), left at the crack of dawn on Saturday, June 21 in a bus bound for Goshen, Virginia. Lodge Advisor, Mr. John Croom, as well as J. Croom also made the trip to Virginia to see the contingent off

on their adventure.

Over six hours later, we had arrived. We checked in and found our

campsites and tents. On Sunday morning, training took place to show all participants how to properly use the tools out in the woods, and also how to keep safe, and how to minimize our impact on the area (through the principles of Leave No Trace.)

Finally, Monday morning rolled around and the real fun began. By quarter to eight that morning, after already being awake for two hours, all the participants, including the ten members from our lodge, were on busses heading to Covington, Virginia and the work site. Once there, we began our cheerful service: building trails. We worked in the hot southern sun from 9 a.m. each morning until around 3:30 p.m. each afternoon. Then we boarded the busses and headed back to camp. This was the schedule every day during the week, except for the recreation day. Each participant could pick an activity, ranging from whitewater rafting to a local tour, and on a certain day (this day was assigned) we got the day off. Everyone from Lowwapaneu ended up choosing the local





tour, but since we were all split up among various squads we all took the tour on different days. The tour included a visit to Stonewall Jackson's house in Lexington, Virginia, and visits to VMI (the Virginia Military Institute), the natural bridge, and caverns over thirty stories below the ground. The theme of the week, beyond cheerful service, was leaving a legacy; leaving our mark, which, in this case, was a trail which many people will use for years to come. Every day during our lunch break we looked at people in history who had made an impact and left a legacy, like George Washington, Thomas Jefferson, and Dr. Goodman, to name a few. We re-

flected on the legacies left behind by those great people, and also on the legacy we were leaving behind.

By the time Saturday morning rolled around again, were we more than ready to leave. We worked hard, built

friendships, and of course, had a great time in the Order's spirit. Leaving was not easy though; we all had become best friends with the people in our crew, who were from all over the country, and now it was already time to say goodbye, at least until NOAC, in some peoples' cases. George Washington and Jefferson was the third week in a series of five. Two weeks had come before us, and two after. Each week will leave its own special legacy on the land and the people who use it. And even though the work was tough and we all were tired and beat on the way home, it was worth it.

When we joined the Order of the Arrow, we made a pledge. This pledge was to uphold brotherhood, cheerfulness, and service. And at AC5, there was plenty of each.

Goal will be to produce up to 500 audio CDs containing the voices of Scouts and adults from the Order of the Arrow Lodge reading short stories from Boy's Life Magazines. Distribute the CDs to area Associations for Retarded Citizens (ARC) and agencies that serve sight impaired and mentally challenged youth.

<u>Why</u>: An additional CD will be produced that will include voices of adults reading stories. This CD will cater to adult members of ARCs. Area schools and agencies are always searching for new educational materials that promote literacy in youth. Schools and agencies that serve the sight impaired and mentally challenged will be thrilled to receive audio CDs containing youth-oriented stories read by, and for youth – at no cost. Area ARCs will also appreciate receiving CDs for their adult members.
